This is done by working in partnership with partner families and the community to build new or rehabilitate existing homes throughout DuPage County. DuPage Habitat has developed units ranging from single-family homes, to duplexes to townhomes. DuPage Habitat builds high-quality, low-frill homes designed to blend seamlessly with the surrounding community. Homes are typically around 1800 square feet with 3-4 bedrooms, 1-2 baths and a garage. Like every builder in DuPage, DuPage Habitat homes must conform with all local building codes, and must pass inspections to ensure quality construction and liveability.

This program will offer donated used and surplus household and construction materials to the general public at greatly reduced prices enabling them to improve their homes with sweat equity.
